THIS PROPERTY OWNERS ASSOCIATION MANAGEMENT CERTIFICATE (the "Management Certificate") is made this 27th day of April, 2022 by **LORENA LAKERIDGE ESTATES HOMEOWNERS' ASSOCIATION, INC.**, a Texas nonprofit corporation ("Association") in accordance with Section 209.004 of Title 11 of the *Texas Property Code*, as amended. The Association hereby states as follows:

1. The name of the subdivision is Lakeridge Estates.
2. The name of the Association is **LORENA LAKERIDGE ESTATES HOMEOWNERS' ASSOCIATION, INC.**, a Texas nonprofit corporation.
3. The subdivision plat for Lakeridge Estates was recorded under Instrument Number 2022008272, of the Official Public Records, McLennan County, Texas.
4. The subdivision is subject to the covenants, conditions and restrictions contained in the Declaration of Covenants, Conditions, Restrictions and Easements for Lakeridge Estates, recorded on March 29, 2022 under Clerk's File Number 2022012337 in the Official Public Records of McLennan County, Texas (the "Declaration")
5. The mailing address of the Association, or name and mailing address of the person or entity managing the Association is amended as follows:

The contractual lien secured such charges, assessments and sums may be subordinate to certain bona fide purchase money liens or mortgages created for improvements covering such lot.

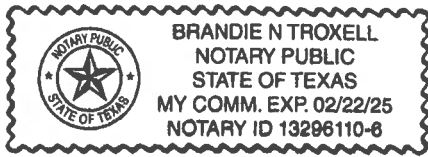
